5. **All requests for clarifications shall be submitted via email to [cdpprocurement.mbma@gmail.com](mailto:cdpprocurement.mbma@gmail.com) on 08<sup>th</sup> December, 2025 by 4:00 PM, The purchaser shall respond to all requests for clarifications by: 11<sup>th</sup> December, 2025 by 4:00 PM.**
6. Quotations should be submitted in physical form (hard copy) either by hand or by post/courier by the deadline and to the address stated above.
7. Bidders have the option to quote for one or more lots, however, all items mentioned in the offered lot must be quoted. A partial quote for the respective Lots will not be accepted. If a quotation shows Goods listed but not priced, their prices shall be assumed to be included in the prices of other items. An item not listed in the quotation shall be assumed not to be included in the quotation.

**Technical Evaluation.** Qualified Vendors from the Request for Empanelment (RFE) no. MBMA/CDP/08/2023-34 dated 17th January, 2024 and RFE no MBMA/CDP/06/825-34 dated 21<sup>st</sup> October, 2024 are eligible to submit their quotation for supply of Lakadong Turmeric Seeds

**8. Evaluation.** The purchaser shall award the contract to the bidder whose offer has been determined to be the lowest priced quotation for the respective lot and is substantially responsive to the request for quotation for that respective lot; further that the bidder is determined to be qualified to perform the contract satisfactorily. If the Price is same for more than 1 (one) vendor then total required quantity may be distributed among all the vendors equally.

**(a) Delivery schedule. (as per Incoterms 2010)** The Goods are required to be delivered within the time as specified in the delivery schedule. Quotations offering delivery beyond this delivery time shall be treated as non-responsive.

**(b) Prices.** Prices shall be in INR (Indian Rupees).

**9. Payment:** within 30 days after delivery and acceptance of goods/service.

**10. Delivery:** To be delivered in Thadlaskein and Laskein Block, West Jaintia Hills District and detail address will be mentioned in the purchase order.

**11. Delivery Schedule:** All items should be delivered within 30 days from the date of issuance of purchase order.

**12. Validity.** Your quotation should be valid for a period of 120 days from the date of your quotation.

**13. Purchase Order.** The purchase order shall be issued by the Meghalaya Basin Management Agency before the end of the validity of the quotation to the eligible bidder who submitted the lowest evaluated quotation for the evaluated lot. Prior to the issuance of the purchase order and after the completion of the evaluation process, the purchaser reserves the right to increase or decrease the requested quantities under this RFQ. The maximum increase allowed to be done to the quotation prior to purchase order signature is +15% and the maximum decrease is -15%.
